Following an examination, if the person has decided to return the device to the owner, or to retain or dispose of it, they may erase any data or files, if they think there is a good reason to do so.

I understand that as a parent or carer of a child at this school that school is working hard to provide a high quality education and a safe working environment for both its students, staff and governors. It is therefore unhelpful to the school if comments about the school life, policies or individual members of staff appear on social media sites. Any comment deemed to be abusive or harmful will be dealt with appropriately. I will ensure that any pictures taken during school events that include other children will not be shared using social media.

Acceptable Use Policy Agreement

I understand that I must use school ICT systems in a responsible way, to ensure that there is no risk to my safety or to the safety and security of the ICT systems and other users.

For my own personal safety:

I understand that the school will monitor my use of the ICT systems, email and other digital communications.

I will treat my username and password like my toothbrush – I will not share it, nor will I try to use any other person's username and password.

I will be aware of "stranger danger", when I am communicating on-line and follow e-safety rules on the school website.

I will not disclose or share personal information about myself or others when on-line.

I will not share any information, images, or comments online that "My Granny" wouldn't like.

I will not meet people off-line that I have not physically met with or are not known to my parents/guardians.

I understand that everyone has equal rights to use technology as a resource in an appropriate manner.

I understand that the school ICT systems are primarily intended for educational use and that I will not use the systems for personal or recreational use unless I have permission to do so.

I will not try (unless I have permission) to make large downloads or uploads that might take up internet capacity and prevent other users from being able to carry out their work.

I will not use the school ICT systems for on-line gaming, social media, on-line gambling, internet shopping, file sharing, or video broadcasting (eg YouTube), unless I have permission of a member of staff to do so.

I will act as I expect others to act toward me:

- I will respect others' work and property and will not access, copy, remove or otherwise alter any other user's files, without the owner's knowledge and permission.
- I will be polite and responsible when I communicate with others, I will not use strong, aggressive or inappropriate language or images that would make someone feel uncomfortable and I appreciate that others may have different opinions.
- I will not take or distribute images of anyone without their prior permission and consent. I will not solicit or distribute images which may cause offence or deemed as illegal.
- I recognise that the school has a responsibility to maintain the security and integrity of the technology it offers me and to ensure the smooth running of the school
- I will only use my personal hand held / external devices (mobile phones) in school if and when I have permission. I understand that, if I do use my own devices in school, I will follow the rules set out in this agreement, in the same way as if I was using school equipment.
- I understand the risks and will not try to upload, download or access any materials which are illegal or inappropriate or may cause harm or distress to others, nor will I try to use any programmes or software that might allow me to bypass the filtering / security systems in place to prevent access to such materials.
- I will immediately report any damage or faults involving equipment or software, however this may have happened.
- I will not open any attachments to emails, unless I know and trust the person / organisation who sent the email, due to the risk of the attachment containing viruses or other harmful programmes.
- I will not install or attempt to install programmes of any type on a machine, or store programmes on a computer, nor will I try to alter computer settings.
- I will never use chat and social networking sites at any time on the school site or try to add members of staff as friends on social networking sites.

When using the internet for research or recreation, I recognise that:

- \bullet I should ensure that I have permission to use the original work of others in my own work
- Where work is protected by copyright, I will not try to download copies (including music and videos)
- When I am using the internet to find information, I should take care to check that the information that I access is accurate, as I understand that the work of others may not be truthful and may be a deliberate attempt to mislead me.
